1. The *Government of Belize* has received financing from the World Bank toward the cost of the *Climate Resilient Sustainable Agriculture Project* and intends to apply part of the proceeds toward payments under the contract for *Construction of Export Corral for BLPA*.
2. The *Belize Social Investment Fund* now invites sealed Bids from eligible Bidders for the *construction of Export Corral for BLPA*.
3. Bidding will be conducted through a national competitive procurement using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" *November 2020* ("Procurement Regulations") and is open to all Bidders as defined in the Procurement Regulations.

5. The bidding document in *English* may be requested by interested eligible Bidders upon the submission of a written application to the address below.
6. Bids must be delivered to the address below on or before *April 24<sup>th</sup>, 2026 at 10:00 a.m. local time*. Electronic Bidding *will not* be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on *April 24<sup>th</sup>, 2026 at 10:30 a.m.*

7. All Bids must be accompanied by a “*Bid Security*” of BZD\$152,000.00
