1. This Invitation for Bids follows the General Procurement Notice for this Project that appeared in Inter-American *Development Bank* of BL-L1045-P00001 of *June 9, 2025*
2. The Government of Belize has received a financing from the Inter-American Development Bank toward the cost of Water and Sanitation Program for Rural Areas, and it intends to apply part of the proceeds of this financing to payments under the Contract for ***Purchase and installation of disinfection equipment and provision of technical assistance for operation and management of the equipment***
3. The Belize Social Investment Fund now invites sealed bids from eligible and qualified bidders for *Purchase and installation of disinfection equipment and provision of technical assistance for operation and management of the equipment*. The delivery period is 200 days
4. The Request for Bids (RfB) will be conducted through the International Competitive Bidding (ICB) procedures specified in the Inter-American Development Bank's Policies for the Procurement of Goods and Works financed by the Inter-American Development Bank GN-2349-15 approved by the Board of Executive Directors of the Bank in May 2019, and effective in January 2020, and is open to all bidders from Eligible Source Countries as defined in the bidding document.
5. Interested eligible bidders may obtain further information can be obtained at the address below during office hours of **8:00 a.m. – 4:00 p.m. Monday to Friday (Local Belize Time)**, except on Public Holidays.
6. Qualifications requirements include Goods must meet technical specifications, financials, power of attorney and other requirements. A margin of preference for certain goods manufactured domestically "shall not", be applied. Additional details are provided in the Bidding Documents.

7. A complete set of the bidding document in *English* may be purchased by interested bidders on the submission of a written application to the address below and upon payment of a non-refundable fee of **BZD \$50.00 (\$25.00 USD)** method of payment will be cash deposited to, or Bank transfer to the Social Investment Fund's bank account only. A request for the Social Investment Fund's banking details can be made at the address below. The Social Investment Fund is not accepting cash payment currently. The bidding document will be sent by email.
8. Bids must be delivered to the address below at or before **October 13th, 2026 at 10:00 a.m. SHARP (Local Belize Time)**. Electronic bidding *will* be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person or on-line at the address below on **October 13th, 2026 at 10:15 a.m.**
9. All bids *shall* be accompanied by a ***Bid Security of 10% of the total bid price for each lot.***
